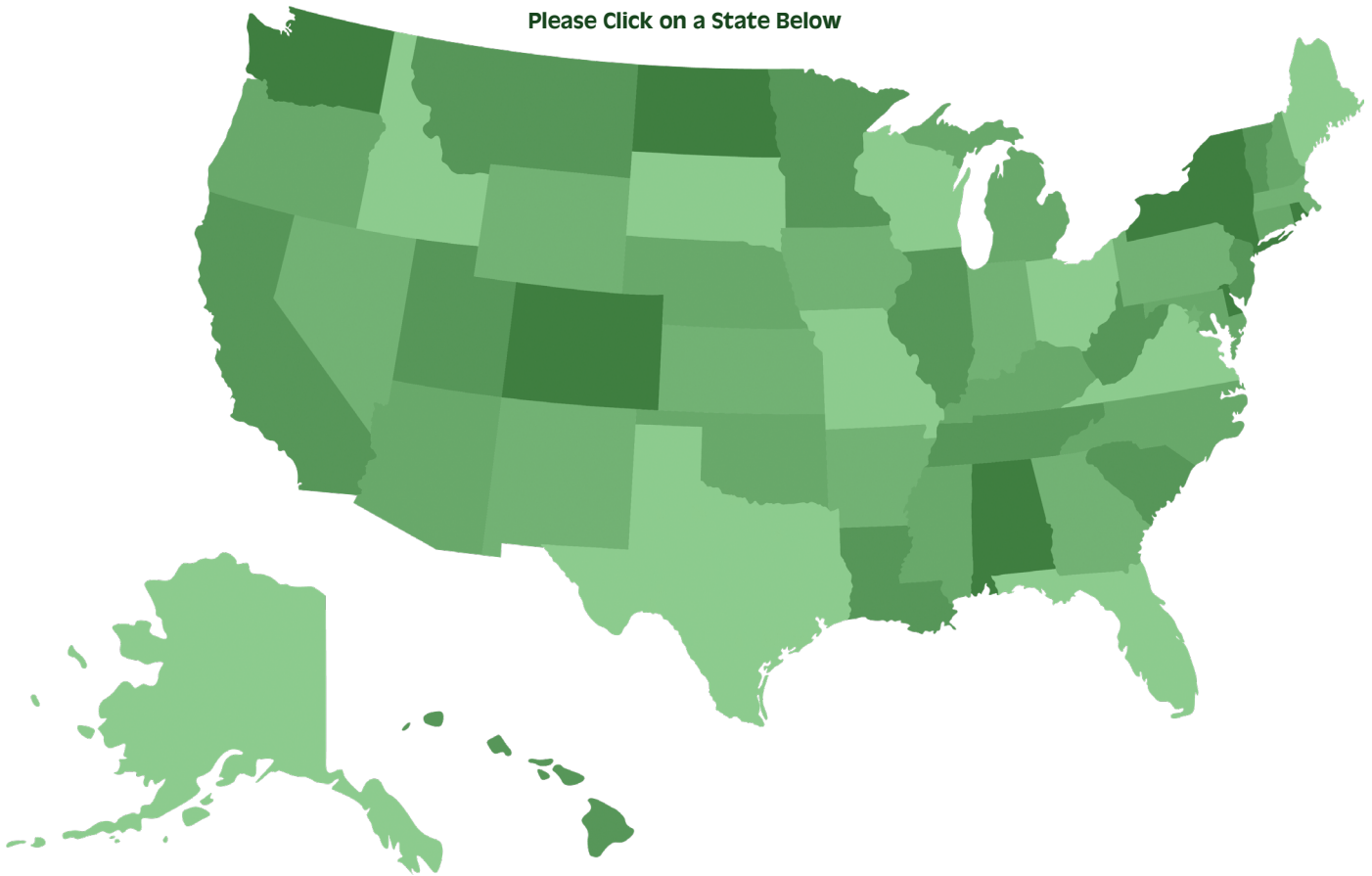




Illuminated Street Name Sign Distributor Map
