


**NOTES:**

1. CABINET IS CONSTRUCTED FROM .125" THICK 5052 H-32 ALUMINUM TO NEMA 3R STANDARDS AND IS POLE MOUNTED.
2. FRONT DOOR IS HINGED ON THE LEFT (AS VIEWED FROM THE FRONT), REAR DOOR IS HINGED ON THE RIGHT (AS VIEWED FROM THE REAR).
3. STANDARD CABINET HAS FRONT DOOR WITH LOUVERS (AND 10" X 16" METAL AIR FILTER & METAL LOUVER COVER), OPTIONAL LOUVERS ON REAR DOOR (WITH FILTER & LOUVER COVER). BOTH DOORS HAVE DOCUMENT POUCH BRACKETS (DOCUMENT POUCH ON REAR DOOR ONLY), THREE POINT LATCHING, A TWO POSITION DOOR STOP, THREE CONCEALED STAINLESS STEEL HINGES PER DOOR, #2 MAIN DOOR LOCKS, A 3/4" DIA. PAD LOCKABLE STAINLESS STEEL HANDLE, AND NEOPRENE GASKET ALL AROUND.
4. CABINET HAS A 19" EIA RACK, WITH PLATED STEEL RACK ANGLES, STANDARD EIA SPACED TAPPED #10-32 HOLES, RACK FRAME 21.25" W X 16.25" D X 32.5" H (15 R.U.)
5. EACH RACK WITH FRONT & REAR DOOR SWITCH BRACKETS.
6. CABINET HAS A FAN PLENUM PLATE FOR SINGLE 4" FAN. (OPTIONAL DUAL 4" FAN FANPLATE)
7. CABINET HAS INTERNAL SIDE WALL MOUNTED REINFORCEMENT POLE MOUNT STIFFENER CHANNELS ON EACH SIDE, AND (2) POLE MOUNT BRACKETS INSTALLED ON LEFT SIDE.
8. ALL HARDWARE IS STAINLESS STEEL.
